Overall, Senator Manchin secured **\$166,961,840** in funding for **88** critical Congressionally Directed Spending Requests, also known as “**earmarks**”, across the Fiscal Year 2022 Appropriations Bills.

The following 3 requests totaling \$4,459,103 were made by Senator Manchin on behalf of West Virginia constituents but were funded outside of the Fiscal Year 2022 Appropriations process:

Beckley Airport Taxiway Construction (\$2,934,447):

Completes the Aerospace Site Development for Raleigh County Memorial Airport, including development of 2500 feet of taxiway and apron for runway access (this request was funded through a combination of FAA Discretionary and ARP funding).

Kanawha River Basin Study (\$1,500,000):

Provides a new start and full funding for the Kanawha River Basin study to be completed by the Corps of Engineers, in response to the severe flooding over the past several years.

Matewan Mine Wars Museum Recovery Project (\$24,656):

Provides funding to the WV Mine Wars Museum to expand and recover from the pandemic (this request was funded through IMLS ARP funding).
